Mamo is designed to automate and optimize yield strategies across decentralized finance ("**DeFi**") platforms. ### 1. SCOPE

This Privacy Policy applies to personal information processed by us, including on our websites and other online or offline offerings. To make this Privacy Policy easier to read, our websites and other offerings are collectively called "Services."

**An Important Note:** This Privacy Policy does not apply to any personal information that may be collected or processed by third party users of the Protocol ("**Third Party Protocol Users**"). Such Third Party Protocol Users' respective privacy policies govern their collection and use of personal information.

### 2. PERSONAL INFORMATION WE COLLECT

The categories of personal information we collect depend on how you interact with us, our Services, and the requirements of applicable law. We collect information that you provide to us, information we obtain automatically when you use our Services, and information from other sources such as third-party services and organizations, as described below.

## A. Information You Provide to Us Directly

We may collect personal information automatically when you use our Services:

#### **Automatic Data Collection**

We may collect certain information automatically when you use our Services, such as your Internet protocol (IP) address, user settings, MAC address, cookie identifiers and other unique identifiers, browser or device information, location information (including approximate location derived from IP address), and Internet service provider. We may also automatically collect information regarding your use of our Services, such as pages that you visit before, during and after using our Services, information about the links you click, the types of content you interact with, the frequency and duration of your activities, and other information about how you use our Services.

## Cookies, Pixel Tags/Web Beacons, and Other Technologies

We, as well as third parties that provide content or other functionality on our Services, may use cookies, pixel tags, local storage, and other technologies ("**Technologies**") to automatically collect information through your use of our Services.

### Cookies

Cookies are text files stored on your device to uniquely identify your browser or to store information or settings in the browser to help you navigate between pages efficiently, remember your preferences, enable functionality, help us understand user activity and patterns, and facilitate online advertising.

## Pixel Tags/Web Beacons

A pixel tag (also known as a web beacon) is a piece of code embedded in our Services that collects information about engagement on our Services. We may use pixels in our email campaigns that allow us to collect your email and IP address as well as the date and time you open an email or click on any links in the email. The use of a pixel tag allows us to record, for example, that a user has visited a particular

web page. We may also include web beacons in e-mails to understand whether messages have been opened, acted on, or forwarded.

### Other

Local storage technologies, like HTML5, that provide cookie-equivalent functionality but can store larger amounts of data, including on your device outside of your browser in connection with specific applications.

## **Operationally Necessary**

This includes Technologies that allow you access to our Services, applications, and tools that are required to identify irregular website behavior, prevent fraudulent activity and improve security or that allow you to make use of our functionality;

### Performance-Related

We may use Technologies to assess the performance of our Services, including as part of our analytic practices to help us understand how individuals use our Services ( see Analytics below );

## **Functionality-Related**

We may use Technologies that allow us to offer you enhanced functionality when accessing or using our Services. This may include identifying you when you sign into our Services or keeping track of your specified preferences, interests, or past items viewed;

### **Analytics**

We may use Technologies and other third-party tools to process analytics information on our Services. Some of our analytics partners include:

### **B. Information Collected from Other Sources**

We may obtain information about you from other sources, including through third-party services and organizations. #### 3. HOW WE USE YOUR INFORMATION

We use your information for a variety of business purposes, including to provide our Services, for administrative purposes, and to market our products and Services, as described below.

#### A. Provide Our Services

We use your information to fulfill our contract with you and provide you with our Services, such as:

- Managing your information and accounts;
- Providing access to certain areas, functionalities, and features of our Services;

- Debugging to identify and repair errors with our Services;

- Enforcing our agreements and policies; and
- · Complying with our legal obligations.

# C. Marketing our Products and Services

We may use personal information to provide you with tailored content, such as through email campaigns. We may provide you with these materials as permitted by applicable law. ## **D. Other Purposes**

We also use your information for other purposes as requested by you or as permitted by applicable law.

#### Consent

We may use personal information for other purposes that are clearly disclosed to you at the time you provide personal information or with your consent.

## De-identified and Aggregated Information

We may use personal information and other information about you to create deidentified and/or aggregated information, such as de-identified demographic information, de-identified location information, information about the device from which you access our Services, or other analyses we create.

## **Share Content with Friends or Colleagues**

Our Services may offer various tools and functionalities. For example, we may allow you to provide information about your friends through our referral services. Our referral services may allow you to forward or share certain content with a friend or colleague. Please only share with us contact information of people with whom you have a relationship (e.g., relative, friend, neighbor, or co-worker).

### 4. HOW WE DISCLOSE YOUR INFORMATION

We disclose your information to third parties for a variety of business purposes, including to provide our Services, to protect us or others, or in the event of a major business transaction such as a merger, sale, or asset transfer, as described below.

### A. Disclosures to Provide our Services

The categories of third parties with whom we may share your information are described below.

### **Service Providers**

We may share your personal information with our third-party service providers who use that information to help us provide our Services. This includes service providers that provide us with IT support, hosting, payment processing, customer service, and related services.

## **Business Partners**

We may share your personal information with business partners to provide you with a product or service you have requested. We may also share your personal information to business partners with whom we jointly offer products or services.

### **Business Transfers**

#### APIs/SDKs

### **Legal Requirements**

We may disclose your personal data where required to do so to protect legal rights or under any law, regulation, court order or other legal imperative.

### **B.** Disclosures to Protect Us or Others

We may access, preserve, and disclose any information we store associated with you to external parties if we, in good faith, believe doing so is required or appropriate to: comply with law enforcement or national security requests and legal process, such as a court order or subpoena; protect your, our, or others' rights, property, or safety; enforce our policies or contracts; collect amounts owed to us; or assist with an investigation or prosecution of suspected or actual illegal activity.

## C. Disclosure in the Event of Merger, Sale, or Other Asset Transfers

If we are involved in a merger, acquisition, financing due diligence, reorganization, bankruptcy, receivership, purchase or sale of assets, or transition of service to another provider, your information may be sold or transferred as part of such a transaction, as permitted by law and/or contract.

## **Email and Telephone Communications**

Note that you will continue to receive transaction-related emails regarding products or Services you have requested. We may also send you certain non-promotional communications regarding us and our Services, and you will not be able to opt out of those communications (e.g., communications regarding our Services or updates to our Terms or this Privacy Policy).

#### "Do Not Track."

Do Not Track ("**DNT**") is a privacy preference that users can set in certain web browsers. Please note that we do not respond to or honor DNT signals or similar mechanisms transmitted by web browsers.

### Cookies

You may stop or restrict the placement of Technologies on your device or remove them by adjusting your preferences as your browser or device permits. However, if you adjust your preferences, our Services may not work properly.

## **Your Privacy Rights**

In accordance with applicable law, you may have the right to:

## Withdraw your Consent

to our processing of your personal information.

## 6. SECURITY OF YOUR INFORMATION

We take steps to ensure that your information is treated securely and in accordance with this Privacy Policy. Unfortunately, no system is 100% secure, and we cannot ensure or warrant the security of any information you provide to us. We have taken appropriate safeguards to require that your personal information will remain protected and require our third-party service providers and partners to have appropriate safeguards as well. To the fullest extent permitted by applicable law, we do not accept liability for unauthorized disclosure.

By using our Services or providing personal information to us, you agree that we may communicate with you electronically regarding security, privacy, and administrative issues relating to your use of our Services. If we learn of a security system's breach, we may attempt to notify you electronically by posting a notice on our Services, by mail or by sending an email to you.

## 7. INTERNATIONAL DATA TRANSFERS

We may revise this Privacy Policy from time to time in our sole discretion. If there are any material changes to this Privacy Policy, we will notify you as required by applicable law. You understand and agree that you will be deemed to have accepted the updated Privacy Policy if you continue to use our Services after the new Privacy Policy takes effect.
